- MINIMUM REQUIRED:** 2 copies for ASU Hayden Library
- FEES:** Binding - \$20.00 per copy for ASU graduates
\$30.00 per copy for other schools documents
- MICROFILMING:** All **dissertations** must be microfilmed.
Fee is \$55.00 (Doctoral)
\$45.00 (Masters)
Open-Access Publishing (Optional) \$95.00
- COPYRIGHT:** Optional – Fee is \$65.00 (in addition to micro)
(To copyright a **thesis**, *you must also microfilm*)
- LENGTH OF TIME:** Binding usually takes 4-6 months.
- SHIPPING FEES:** Additional copies can be shipped within the U.S. for \$5.00 per copy.
- PAPER:** Use good quality, acid free paper. 24lb weight is the minimum. All copies should be printed on the same weight paper. If different weight paper is used, there is an additional charge of \$25.00 *per paper weight change*.
- DOCUMENT LENGTH:** Minimum thickness is .5". Stubbing, which is \$3 per copy, is required for documents thinner than .5". If the document is thicker than 2 inches, it **MUST** be split into two volumes. There is an additional charge of \$5 per copy for the stamping of Volume II or I on the spines.
* Using a heavier weight of paper will increase thickness.
- LENGTH OF TITLE:** You are allowed **50** characters (including punctuation, spaces, etc.) If you exceed **50** characters there is an additional charge of \$5 per copy. If you exceed **80**, the additional charge is \$13 per copy. Exceeding **110** is an additional \$24 per copy and exceeding **150** characters is an additional charge of \$40 per copy.

LENGTH OF LAST NAME: You are allowed 9 spaces for your last name on the spine. If you exceed there is an additional charge of \$4.00 per copy up to 13 characters. Over 13 characters is an additional \$11.00 per copy.

**MISCELLANEOUS
CHARGES
AND INFORMATION:**

Unusual character stamping including, but not limited to, the following: formulas, symbols, chemical elements, lowercase letters, super (or sub) scripts, and underlining is an additional \$16 per copy. (Another option is to spell out the symbol or element, if possible.)

Any changes after submission to the Bookstore, regardless of who identified the mistake, will be subject to flat \$10.00 page substitution fee and any additional charges that may be incurred because of corrections.

For any document, whether thesis or dissertation that will be microfilmed, the author must provide an additional copy of the title and abstract pages. **If this is not provided, the Bookstore will make an additional copy of each for a fee of \$2.00.**

You may submit any personal or departmental copies of your document at any time; please be aware that if you would like only **one** copy an extra fee of \$15.00 will be implemented.

SUBMISSION BY PROXY:

If a proxy must be used, all submission requirements must be met as stated, including the author's signature on the "Proquest" Thesis/Dissertation Agreement Form. Accompanying the proxy should be the necessary proxy identification forms provided by the Division of Graduate Studies. The Bookstore will not accept mailed-in documents. If a master or doctoral candidate is not able to represent themselves, they must arrange to get the required (minimum of 2) documents to their proxy in a timely manner to assure that they will make the deadline.
